As you are aware, one of the Petroleum Institute of East Africa (PIEA) objectives is to provide the industry stakeholders and policy makers with reliable statistical data and literature.

The PIEA has continued to meet this objective by sharing information and data through the Petroleum Insight (PI) Magazine which is published on a quarterly basis.

The PIEA secretariat collects and collates data for publishing in the PI in liaison with the Industry Data Verification Committee on the basis of the Petroleum Act 2019 and in compliance with the Competition Act 2010

To enhance governance and reliability, the PIEA Board approved the digitization of PIEA data collation and reporting systems.

To ensure that our data unit remains sustainable we shall from the Board approved resolution be charging a nominal fee for data sets that are detailed beyond what is published in the PI every quarter.

The nominal fees per every annual quarter for different data sets/clusters are as below:

### **The Data Digitization Platform**

#### **Members Obligations:**

1. Only the PIEA Secretariat designate will have total rights of the tool and Members can buy their own power Business Intelligence (BI) license
2. Members will be uploading their data online-similar to the itax-KRA portal that will be availed to them.
3. Members will be allocated a username and have low level access. (Data will be locked and limited to only what they are allowed to see as will be documented by PIEA Secretariat-Rights of Members access)
4. The PIEA Secretariat will be able to monitor the number of accesses made to the portal and the length of stay too.
5. Members will be given access to the portal for data upload.
6. The Energy Petroleum Regulatory Authority (EPRA), the Kenya Revenue Authority (KRA), The Kenya Pipeline (KPC) and PIEA have a joint data vetting and verification forum that ensures compliance and reliability of data so if Members prefer to submit data directly to EPRA and not to PIEA's portal that is in order as well.

#### **NOTE:**

EPRA's legal requirement on submission of data was in place before the Competition Act and therefore it is presumed that the data submission process is not in conflict with the Competition Act 2010.
